Scope of Work:

Field investigation

Investigation to obtain the subsurface stratification in the proposed project area and collection of soil samples for lab testing of the same to obtain the physical and engineering properties to arrive at the foundation design parameters

Details of work under the above scope

- 1. Mobilization of equipment and personnel to the project site, setting up of the equipment and carry out the field investigations at site and demobilization of the same on completion of work
- 2. Making boreholes of diameter and depth below existing ground level as per the instruction of Engineer-in-charge from TKMCE.
- 3. Standard penetration tests (SPT) are to be conducted in each borehole at 1.5 m intervals in depth or change of strata whichever is earlier as per IS 2131:1981 and as per site condition.
- 4. Disturbed/ undisturbed soil samples are to be collected from each borehole at regular intervals in depth or change of strata, whichever is earlier as per IS 2132-1986 or according to site condition. The samples collected should be marked with identification numbers indicating depth, number and type of sample etc. duly packed and preserved and transported to the laboratory for testing in accordance with the standard and general practice.
- 5. Recording the depth of ground water table in each borehole after 24 hours of boring.

Manpower requirement

Engineer (Graduate/ Diploma Holder) - one person per site Supporting professionals (including operators) - As required

Minimum eligibility condition

- 1. The agency must have a 3 years of experience
- 2. The agency must be registered under company act/society act/partnership firm
